PETITION TO SET ASIDE NOMINATING PETITION OF
RYAN ROY SUPLER

AND NOW, this 14th day of March 2023, comes Petitioner Cindy Hochhalter by and through legal counsel, by and through her attorney, Law Office of Farley G. Holt and more specifically Farley G. Holt, Esquire, and files this Petition to Set Aside Nominating Petition of Ryan Roy Supler pursuant to 25 P.S. § 2872.1 stating as follows:

1. Petitioner Cindy Hochhalter ("Hochhalter") is an adult individual residing at 124 Nicholas Lane, York, PA 17402.
2. Petitioner is a registered voter in York County, Pennsylvania.
3. Petitioner is registered as a member of the Democrat Party.
4. Respondent Ryan Roy Supler ("Supler" or "Respondent") is an adult individual residing at 258 Walnut Street, York, PA 17403.
5. On or about March 7, 2023, Supler filed a nominating petition for the office of York County Clerk of Courts, York County, Pennsylvania.
6. Supler filed said nominating petition under the Democratic Party.

7. As a registered and enrolled member of the Democratic Party, petitioner has standing to file the instant petition.
8. Attached as Exhibit A is Supler's Nominating Petitions. Also Attached is Exhibit B is a spreadsheet correlating with the petitions showing which signatures are not registered voters, or not the area and signed.

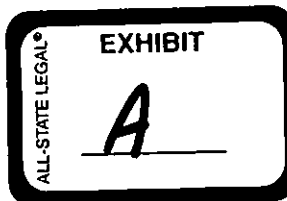


