The undersigned Electors of the City of York, by and through their undersigned counsel, file the following Petition pursuant to 11 Pa.C.S. § 10801(b) Requesting the President Judge of this Honorable Court Fill the Vacancy in the Office of Mayor of York City, and in support thereof aver as follows:

- 1. The following are Qualified Electors of the City of York:

- Petitioners assert that there is a vacancy in the Office of Mayor of the City of
 York.
- 3. Respondent, Michael Helfrich ("Respondent"), was elected Mayor of the City of York in the November 2021 General Election.
- 4. As such, Respondent is an "elected official" as defined in the Third Class City Code ("Code"). See 11 Pa.C.S. § 10701(a)(1).
- 5. Respondent did not attend or otherwise participate in the York City Council's reorganization meeting held on Tuesday January 4, 2022.
- 6. Respondent did not hold or otherwise participate in any inauguration or swearingin ceremony on Tuesday January 4, 2022, or within fourteen (14) days thereof.
- 7. Respondent did not take the oath of office on Tuesday January 4, 2022, or within fourteen (14) days thereof.
- 8. On January 24, 2022, Respondent, via a livestream video platform, finally took the oath of office some twenty (20) days following the York City Council's reorganizational meeting.
- 9. Upon information and belief, Respondent did not present a signed affidavit to the City Clerk certifying that he was a resident of York City for not less than one (1) year prior to the date of his election as required by Section 11201 of the Code, 11 Pa.C.S. § 11201(3)-(4).
- 10. Respondent's failure to attend the York City Council's reorganizational meeting, failure to be inaugurated, failure to timely take the oath of office, and failure to submit the

required affidavit result in the Respondent being disqualified to hold the office of Mayor of York City, thereby creating a vacancy therein.

- who fails to qualify in accordance with sections 10904 (relating to offices to be held until qualification of successors) and 10905 (relating to oath of office, violation of oath and penalty).

 . . shall be ineligible to qualify. A vacancy shall exist in the office, and an individual shall be appointed to fill the vacancy in the manner provided under this part." 11 Pa.C.S. § 10701(b) (emphasis added).
- 12. Section 10904 of the Code requires that "[i]f an elected official fails to appear at the organizational meeting of council to demonstrate the official's qualifications for office and to take the oath of office either: (1) the official must fully qualify for office and take the oath of office within 14 days of the date of the organizational meeting of council; or (2) the office of that elected official shall be deemed to be vacant and the vacancy shall be filled in the manner provided by this chapter." 11 Pa.C.S § 10904(b)(1)-(2).
- 13. Respondent failed to appear at the organizational meeting of the York City Council on Tuesday, January 4, 2022, to demonstrate his qualifications for office and to take the oath of office.
- 14. Respondent failed to qualify for office and take the oath of office within 14 days of the January 4, 2022, organizational meeting of the York City Council.
- 15. Pursuant to Section 10905 of the Code, "[e]ach officer of the city, whether elected or appointed, shall, before entering upon the officer's respective duties, take and subscribe an

oath or affirmation of office pursuant to 53 Pa.C.S. § 1141 (relating to form of oaths of office)."

11 Pa.C.S § 10905(a).

- 16. Respondent failed to timely take and subscribe an oath of affirmation of office as required by Section 10905 of the Code.
- 17. Pursuant to Section 11201 of the Code, "[t]he qualifications for office of mayor shall be as follows: . . . "(4) Before being sworn into the office of mayor, an individual elected to mayor must present a signed affidavit to the city clerk certifying that the individual is in accordance with the requirement under paragraph (3)." 11 Pa.C.S § 11201.
- 18. Upon information and belief, Respondent failed to present a signed affidavit to the City Clerk certifying that he was a resident of York City for not less than one (1) year prior to the date of his election as required by Section 11201 of the Code. 11 Pa.C.S. § 11201(3)-(4).
- 19. Pursuant to Section 11202 of the Code, "[t]he mayor shall be inaugurated and take the oath of office in accordance with sections 10904 (relating to offices to be held until qualification of successors) and 10905 (relating to oath of office, violation of oath and penalty) on the first Monday of January after the regular municipal election. If the first Monday is a legal holiday, the mayor shall be inaugurated and take the oath the first day after that day or as soon after that day as possible." 11 Pa.C.S § 11202.
- 20. As set forth above, Respondent failed to be inaugurated and take the oath of office in accordance with Sections 10904 and 10905 on the first Monday of January after the regular municipal election.

- 21. In this case, the first Monday of January was a City of York government holiday, however, the City Council's reorganizational meeting was held on the following Tuesday, January 4, 2022.
- 22. Respondent was not inaugurated on Tuesday January 4, 2022, and was not inaugurated "as soon after that day as possible"; rather, Respondent simply took the oath of office via a livestream video platform twenty (20) days later on January 24, 2022.
- 23. The Optional Third Class City Charter Law, 53 P.S. §§ 41101, et seq., and the York City Codified Ordinances, do not impact the applicability of the relevant provisions of the Code. See 53 P.S. § 41301. In fact, the City's Codified Ordinances repeatedly cite to and cross-reference the Code, and, in any event, do not attempt to provide additional or different qualifications for the Office of Mayor. See Codified Ordinances of York, Pennsylvania, Art. 123.02.
- 24. As a result of Respondent's failure to appear at the organizational meeting of the York City Council to demonstrate his qualifications for office and to take the oath of office, or, failing that, fully qualify for office and take the oath of office within 14 days of the date of the City Council's January 4, 2022 organizational meeting of Council, "the office of [Mayor] shall be deemed to be vacant and the vacancy shall be filled in the manner provided by this chapter. 11 Pa.C.S § 10904(b)(2).
- 25. Section 10801 of the Code provides that "[w]ithin 30 days of a vacancy in the office of mayor or other member of council or if an elected mayor or council member has failed to qualify under section 10701 (relating to elected officers, term, reelection and vacancy) prior to

taking office, council must, by a majority of council's remaining members, appoint a qualified

individual to fill the vacant office. 11 Pa.C.S § 10801(a).

26. Section 10801 of the Code provides further that "[i]f a council does not fill a

vacancy within 30 days under subsection (a) or if a vacancy exists in the offices of at least a

majority of the members of council, including the position of mayor, the president judge of the

court of common pleas having jurisdiction within the city, must fill each vacancy upon either the

petition of at least 10 qualified electors of the city or the petition of a majority of the remaining

members of council." 11 Pa.C.S § 10801(b).

27. Petitioners pray this Honorable Court fill the vacancy in the Office of the Mayor

of York City as required by Section 10801(b) of the code, 11 Pa.C.S § 10801(b).

WHEREFORE, Petitioners, respectfully request that this Honorable Court grant their

Petition, declare Respondent, Michael Helfrich, disqualified from holding the office of Mayor of

the City of York, and make an appointment to fill the vacancy in the Office of Mayor of the City

of York.
